



- Damage prevention measures to be discussed






- Amenity Center

In Progress Projects



- A \$9,390 deposit was paid to Shade America, Inc. on 1/5/24 for the install of shade sail at the amenity center playground (Prior to GMS awarded management contract)
- Shade America, Inc. was contacted and scheduled to meet with GMS week of 3/25 to discuss install and did not show and has not returned phone calls

In Progress Projects







- Veterans Park
 - Dead tree in Veterans Park parking lot to be removed
 - Broken benches at Veterans Park to be replaced and repaired
 - Louvered vents to be added to bathroom doors at Veterans Park to improve smell
 - Water fountain at Veterans Park to be repaired

- GMS is working with Security 101 to update the access system in order to secure the Veterans Park bathrooms
- Security 101 will also be cleaning up all exposed wiring in the front office, including security camera closet
